1. This agreement allows the responsible party the use of Lakeside Swim Club's facility WITH other guests present. Your group will not be the only attendees in the facility and will be open to Lakeside membership during this time period. If a private party is needed, please contact the Aquatics Director.
2. Deposit to hold date: \$50.00
3. Rate: \$100/hour with a 2 hour minimum up to 40 guests (during open hours)
4. Rate \$125/hour with a 2 hour minimum up to 40 guests (private party/closed hours)
5. 20% discount for Lakeside Swim Club Members and Lakeside Gators Parents
6. \$20/hour additional for every 20 guests over 40 with a maximum of 80 guests
7. Lakeside Swim Club Rules must be followed, or guests will be asked to leave. Rules are posted on the Lakeside Swim Club website and posted at the facility.

Lakeside Swim Club Pool Party Contract

1. All events must be approved by the Aquatics Director. The Aquatics Director reserves the right to deny rental to any group or function on the basis of inappropriate use.
2. Deposits are due at the time of booking the event.
3. Final payment must be made at least 1 week before the event or the event will be canceled.
4. Cancellations must be made no less than 48 hours before the event or the deposit will be forfeited.
5. In the event of inclement weather on the day of the event, you must contact the Aquatics Director to reschedule your party. Lifeguards will arrive at the facility, rain or shine, unless notified by the Aquatics Director. No refunds will be given if the Aquatics Director is not notified 3 hours PRIOR to the event start time on the day of your event.
6. NO SMOKING ON LAKESIDE PROPERTY.
7. NO WATER BALLOONS OR SQUIRT GUNS ALLOWED.
8. NO GLASS ON THE PROPERTY.
9. No running or rough play will be tolerated.
10. No sitting, standing, or playing on the lane ropes.
11. No diving in shallow end.
12. No diapers in the pool. Designated swim diapers only.
13. No playing on/with swim team equipment.
14. All pool rules must be followed and will apply to party rentals.
15. There must be 1 adult provided for each 10 children at the party.
16. The renter is responsible for all loose trash and clean-up after the event.
17. The renter hereby assumes and bears the entire risk for damage to the Lakeside Swim Club facility and any other pool equipment resulting from any cause, whatsoever, during the term of this rental agreement. In the event of any loss, Lakeside Swim Club will repair any damage to the facility at the sole expense of the renter.
